 - High Performance: Men's T&F, Women's T&F, RaceWalk
 - Men's-position is still open if there is anyone interested
 - Women's-not present
 - Racewalk-brand new Master's record by MaryAnn Martino. Possibilities for the Run, Jump, Throw program.
 - Long Distance Running:

- Women's- Bids sent out for races. 10-11 responded. 7 championships are going. 3 have happened. 4 more to occur. Attending all the championships and having a presence at these races
- Men's-Trying to recruit and partner with the Mountain and Trail running group. All events are happening in the last 6 months of 2021, but there are different groups participating. Having National Master's Championships in the near future.
- Masters-another open position. Lee has sent out some emails to see if there is any interest.
- General Competitive: Masters T&F, Youth
 - Master's: 5280 Challenge with Association championship ran in June. In August we had National Combined Championships and Mid-America Championships. Things went well. Technical event clinic had some issues with coaches backing out, and meets being canceled. We will see if we can roll over the grant into next year. Give money to support athletes travelling around the world.
 - Youth: Rough season, was able to put together a 5 week season, high school season was pushed into the normal season. Indoor season is up in the air. Trying to work in Saturday meets. Meets will also be open to Master's.
- Officials-Numbers nationwide are down by about ½. We have lost about 10. Due to COVID, expenses, technical issues. Clinics at Air Force and CU in the near future. Email coming out with more details. Official certification will take about 4 hours. Coming up clinic is being set up for new guys.
